- 2. In terms of the provisions of Section 135 of the Companies Act, 2013 and rules made thereunder, the Company is mandatorily required to spend an amount of Rs. 17,32,663/- towards CSR activities in the financial year 2023-24. Although the Board of Directors of the Company have approved an amount of Rs. 18,00,000/- to be spent on CSR activities during FY 2023-24, in case the Company does not spend the excess amount i.e. Rs. 67,337/-, the same would not be considered as unspent amount. However, in case the Company spends the entire amount of Rs. 18,00,000/- towards CSR activities during FY 2023-24, the excess amount i.e. Rs. 67,337/- would be available for set-off in the next 3 years.
